Minutes (Proceeding of formation of the PTA executive committee)

Date: 8.07.2016

Venue: Principal's Office, Golden Jubilee School, Jalna

The meeting was attended by the following:

Principal, Vice Principal, Mr. Mahadev Bhosle, Mr. Anad Jindal, Mrs. Shraddha Jindal, Mr. Jitendra Agrawal, Mrs. Pournami Ruikhedkar, Dr Madhulika Mantri and Mrs. Smita Dahake. Mr. Nandkishore Dambale videographed the proceedings.

Meeting started with the Principal welcoming the members who were present at the lottery.

He explained the rules laid by Maharashtra Government regarding formation of the PTA executive committee.

Then Principal read out the parent nomination received for different classes.

Class LKG- Only one nominee - Mr. Vijay Lahane, father of Shradha. So, he automatically became the parent representative for the class.

Class UKG- Only one nominee - Mrs. Renu Agrawal, mother of Devansh. So, she automatically became the parent representative for the class.

Class 1- There were two nominations, but one parent, Mrs. Shilpa Agrawal was member of PTA committee in 2014-15. So the other parent Mrs. Savita Munde, mother of Kavya Mudhe automatically became the parent representative for the class.

Class 2- Only one nominee - Mrs. Shraddha Jindal, mother of Aryan Jindal. So she automatically became a PTA executive committee member. (Initially, she was considered ineligible as she was a member in 2013-14 and it was felt that the three-year was not there, but after the meeting Principal sought legal opinion and she was considered to be eligible.)

Class 3- Only one nominee - Mrs. Kavita Raut, mother of Ridhi automatically became a PTA executive committee member.

Class 4- Only one nominee - Mrs. Pournima Ruikhedkar, mother of Ishwari, automatically Only one nominee -

Class 5- There were 2 nominees- Mrs. Sheetal Bhakkad and Mr. Anand Jindal submitted nominations. Since, Anand Jindal's wife was already selected as PTA executive committee member for class 2, he became ineligible. So, Mrs. Sheetal Bhakkad, mother of Kanak automatically became a PTA executive committee member.

Class 6- Only one nominee - Mr. Deepak Kamad, father of Pallav. So he automatically became a PTA executive committee member.

Class 7- Only one nominee - Mrs. Shilpa Kendre, mother of Shashank. So she automatically became a PTA executive committee member.

Class 8- Only one nominee - Dr. Jyotsna Bhale, mother of Akash Bhale. So she automatically became a PTA executive committee member.

Class 9 - Three nominations - Dr. Madhulika Mantri and Mrs. Smita Dahake and Mr. Jitendra Agrawal. Mr. Jitendra Agrawal was not initially considered due to the confusion regarding 3 years gap. In the lucky draw Mrs. Smita Dahake, mother of Varad Dahake was selected as a PTA executive committee member. (When after the meeting it became clear that Mr. Jitendra Agrawal was also eligible, he was informed of the same, but he indicated that he was not interested in a re-lottery and that Mrs. Smita Dahake could continue as the class 9 parent representative on the PTA executive committee.)

Class 10- Two nominees -Mrs. Rachan Peety and Mrs. Leela Parimi. Mrs. Rachana Peety was ineligible as she was on the PTA executive committee last year. So Mrs. Leela Parimi, mother of Anirudh automatically became the PTA executive committee member for the class.

Class 11- Only one nominee - Mrs. Varsha Sahni, mother of Garima. So she automatically became a PTA executive committee member.

Class 12- Only one nominee - Mrs. Anita Agrawal mother of Shivani. So she automatically became a PTA executive committee member.

After the selection procedure got over the principal expressed his thanks and assured all present that PTA Executive Committee Meeting would be held soon.
